The meeting was opened by Chairman of the Board, Mr. Michael Norman at 4:58 pm.

II) PUBLIC COMMENTS:

Citizens who desire to address the board on any matter may sign up to do so prior to the meeting. Public comments will be received during this portion of the meeting. Please limit comments to three (3) minutes. No discussion or final action will be taken by the board.

There being no public comments, Mr. Michael Norman closed the Public Comments section at 4:58 pm.

II) CONSENT AGENDA:

All items listed under this selection, Consent Agenda, are considered to be routine by the Board of Directors and may be enacted by one motion. If discussion is desired by the Board, any item may be removed from the Consent Agenda at the request of any Board Member and will be considered separately.

1) Consider adopting a resolution approving the Consent Agenda items and the appropriate resolutions for each of the following:

(A) Approve the minutes of the August 23, and the September 6, 2023, Board Meetings.

(B) Approve September 2023 financials.

Motion by Mr. Tyler Johnson, second by Mr. Greg Strasburger to adopt a resolution approving the Consent Agenda Items.

A verbal vote was called and was unanimous.

II) REGULAR AGENDA:

A). Receive a presentation from Amanda Carlson, Director of Marketing and Communications with TEDC, regarding the rebranding process and timeline.

Ms. Carlson presented on the talkStrategy workshop, the takeaways from the workshop and what the Board could expect moving forward with talkStrategy. She stated that the timeline for the results to be presented would be roughly 6-8 weeks.

B). Discuss and possibly take action on Temple Health and Bioscience Economic Development District subcommittee appointments and term limits.

The Board discussed term limits and election cycles. No adjustments to the current policies are required.

C). Discuss and possibly take action on the Scottsdale Insurance Company proposal for structure damage to the physical structure in the amount of \$2,318.85.

E). Receive an update from the real estate holdings subcommittee regarding the development of the property with activities such as property maintenance, drainage, sewage and surveys.

F). Receive an update from the THBD/TEDC engagement subcommittee.

Mr. Norman gave a brief overview of discussions with TEDC. More presentations and updates will be coming from TEDC in the near future.

No action was taken.
